Geesthacht, 31. März 2021 Introduction of XInvoice in accordance with eGovernment Law (EGovG)

Dear Sir or Madam,

From 27/11/2019 we have been required to use electronic invoices in the form of a structured data set (XInvoice) according to European Standard 16931 on digital channels and process them without media discontinuity, in line with the elnvoicing Act of 04/04/2017 (BGBI. I, 770 et seg.) and the elnvoicing Ordinance of the German Federal Government (E-RechV). At the same time, we are required to implement requirements for revision-safe archiving.

Since 27th November 2020, electronic invoicing will be mandatory when invoicing for orders exceeding 1,000 euros. Exceptions to this obligation are set out in Sec. 3 (3) of the Federal elnvoicing Ordinance. We hereby request that you make use of the available elnvoicing options.

Sec. 4 of the E-RechV sets out the requirements for the invoice data model and the transmission of invoices. Electronic invoices must comply with the terms of use of the platform as well as complying with European Standard 16931-1-2017 and with E-RechV. As such, a mere image file or a simple PDF document is not an electronic invoice. Further information you can get on https://www.e-rechnung-bund.de.

Electronic invoices should be transmitted using the federal government's invoice receipt platform (OZG-RE), which is available at https://xrechnungbdr.de. For the invoice to be correctly assigned to us, it is mandatory that you provide our route identification number 992-80187-74. You can also send us XInvoices directly by email to xrechnung@hereon.de.

You can also send attachments with your electronic invoice. The following Formats are currently permitted: PDF documents, images (PNG, JPEG), Text files (CSV), Excel spreadsheets and OpenDocument spreadsheets.
